This warranty is extended only to the original purchaser from authorized dealers and/or distributors and is non-transferable and subject to the terms, requirements and limitations provided in this limited warranty.

Limited Warranty Coverage: Panels covered under this warranty are warranted for a period of Five (5) years from date of purchase to:

- 1. Be free from substantial defects in material and workmanship.
- 2. Not rot, rust, corrode, develop structural surface cracks or require painting or refinishing.
- 3. Not delaminate due to materials when installed and used according to installation and use recommendations.
