Limited Warranty: NuAlum composite sign panels distributed by Nudo Products, Inc., 1500 Taylor Avenue, Springfield, IL 62703 are warranted for a period of Two (2) years from the date of purchase to be free from substantial defects in material and workmanship. This warranty is extended only to the original purchaser from authorized dealers and/or distributors and is non-transferable and subject to the terms, requirements and limitations provided in this limited warranty.

Limited Warranty Coverage: Panels covered under this warranty are warranted for a period of Two (2) years from date of purchase to:

- 1. Be free from substantial defects in material and workmanship.
- 2. Not rot, rust, corrode, develop structural surface cracks or require painting or refinishing.
- 3. Not delaminate due to materials when installed and used according to installation and use recommendations.
